This is with reference to our earlier Circular No. 47 dated 20.10.2021, as given below regarding **Webinar on “Rebate of State & Central Taxes and Levies (RoSCTL) Scheme - An Overview”** scheduled on **02.11.2021 at 3.00 PM.**

As you are aware that RoSCTL Scheme has been extended for export of garments and made-ups w.e.f. 1st January 2021 to 31st March 2024, by Ministry of Textiles vide its Notification dated 13.8.2021. However, this Scheme is going to be implemented by the Department of Revenue.

Duty Drawback Division, Department of Revenue as well as DG (Systems) have already issued guidelines for implementation of RoSCTL Scheme. Scroll generation of RoSCTL Scheme has already started. However, still a number of issues are arising. **Hence, this Webinar has been organized by Directorate General of Taxpayer Services (DGTS), Department of Revenue and AEPC jointly, wherein Principal ADG, DGTS; Principal ADG, DG Systems; Director, Drawback, senior officers belonging to Department of Revenue, Ministry of Finance would be present, for making presentations as well as taking questions in the Question & Answer Session and addressing the issues.**

Subject: Webinar on ‘Rebate of State & Central Taxes and Levies (RoSCTL) Scheme – An Overview scheduled on 02.11.2021

Dear Members,

As you are aware GOI has fixed an export target of US\$ 20bn for the Apparel sector for current financial year. Ministry of Textiles has been constantly supporting the Apparel industry through its export promotion policies. In this context MOT vide its notification no 12015/11/2020-TTA dated 13.8.2021 had announced continuation of Scheme for Rebate of State and Central Taxes and levies (RoSCTL) on export of garments and made-ups to enhance competitiveness of these sectors, w.e.f. 01st January 2021 to 31st March 2024 for apparel/garments. With effect from 01.01.2021, the scheme provides for remission amount in the form of transferable duty credit issued to a person and maintained in the electronic duty credit ledger in the customs automated system. Subsequently, vide [Circular No. 22/2021-Customs dated 30/09/2021](#) issued by Department of Revenue and Advisory No. 06/2021 dated 01/10/2021 issued by DG (Systems), detailed procedure and formats for claiming RoSCTL were given. The same was shared by [AEPC vide Circular No. 44 dated 02.10.2021](#).

AEPC has been receiving a number of requests from its member exporters about issues faced towards the implementation of the RoSCTL. Hence to spread awareness and resolving these issues, Directorate General of Taxpayer Services (DGTS) Delhi and Kolkata Zonal Units and AEPC are organizing a Pan-India webinar on Tuesday 2nd November 2021 at 1500 hrs. Since the scheme is being implemented by the Dept of Revenue, both the Policy Wing and Implementation Wing of the Dept of Revenue will be participating in the Webinar to address all the issues related to the Scheme. The ROSCTL scheme has been continued with the rates, as notified by the Ministry of Textiles vide Notification no.14/26/2016-IT (Vol.II) dated 08th March 2019 with the same rates. For all other textile items, the RODTEP scheme has been made applicable.

- [AEPC Circular No. 36 dated 13.08.2021](#) regarding continuation of RoSCTL and [Circular No. 44 dated 02/10/2021](#) regarding implementation of RoSCTL.

- With regard to implementation guidelines, the Dept. of Revenue had issued [Circular No. 22/2021-Customs dated 30/09/2021](#) regarding issue of scrips, its use, transfer and the conditions and restrictions governing them and No. [75/2021-Customs \(N.T.\) dated 23.09.2021](#) regarding Regulations for use, transfer, maintenance etc. of Electronic Duty Credit Ledger.

- The notification No. 77/2021-Customs (N.T.) has been issued as a consequence of Ministry of Textiles' RoSCTL scheme notification No. 12015/11/2020-TTP dated 13.08.2021 containing scheme guidelines and [No. 14/26/2016-IT\(Vol.II\) dated 08.03.2019](#) which provided the applicable rates along with caps for eligible products.
