**IMPORTANT**

Dear Members,

1. This is in continuation of [AEPC Circular No. 72 dated 02.02.2022](#) informing the Trade regarding extension of last date for submitting applications for scrip based FTP schemes as 28/02/2022 and further Reminder thereof dated 24/02/2022 and Reminder-2 dated 25/02/2022 vide mass mail. In the last circular, AEPC had informed the members about the list of Firms who had not claimed RoSCTL Benefits, as informed by DGFT and advised the Members, especially those indicated in the list, to claim their refunds within the extended timelines of 28th Feb 2022.

2. However, many members shared that they were facing difficulty in submission of applications within the extended timeline of 28/02/2022 and requested for further extension. Hence AEPC had requested DGFT for a further extension of date for submission of applications. **We are happy to share that now DGFT vide their Notification No. 58/2015-**

**2020 dated 07/03/2022 has extended the last date for filing old ROSL and ROSCTL claims till 15/3/2022. However, trade may kindly note that it has been informed categorically that no further extension will be provided for filing ROSL/ ROSCTL claims applications for exports made till 31/12/2020. Members are once again requested to avail of this last opportunity to clear their claims for exports made till 31/12/2020.**

**3.** Members may also note the following **Amendments made by DGFT in [FTP 2015-20](#)** vide their Notification No. 58/2015-2020 dated 07/03/2022 :

**a. Amended Para 3.04A**

The total reward which may be granted to an IEC holder under the MEIS shall not exceed Rs.2 Crore per IEC on exports made in the period 01.09.2020 to 31.12.2020 [period based on Let Export Order (LEO) date of shipping bill(s)]. Any IEC holder who has not made any export with LEO date during the period 01.09.2019 to 31.08.2020 or any new IEC obtained on or after 01.09.2020 would not be eligible for submitting any claim for benefits under MEIS for exports made with effect from 01.09.2020.

**b. Amendment in Para 3.13A**

As indicated above, with effect from 07.03.2022, the last date for submission of online applications for certain scrip based Schemes and applicable late cut on such applications would be:

in the period 01.01.2020 to 31.03.2020 only)		
(iii) ROSCTL (for exports made in the period 07.03.2019 to 31.12.2020	15.03.2022	Nil
(iv) ROSL (for exports made upto 06.03.2019 for which claims have not yet been disbursed under scrip mechanism)	15.03.2022	Nil

**4. No further applications would be allowed to be submitted after the prescribed last date (as above) as they would become time-barred. Late cut provisions shall also not be available for submitting claims thereafter.**
