He was elected to the Executive Committee of AEPC in 1982 and served for 41 consecutive years. He was elected Chairman four times, a unique achievement in the history of the council. He emphasized the production of man-made fiber (MMF) garments and medical textiles, influencing the government to include MMF in the PLI scheme.

As the President of Tirupur Exporters Association for 27 years, he was instrumental in growing Tirupur's exports from Rs 15 crore in 1985 to Rs 26,000 crore in 2016-17.

Dr. A. Sakthivel has served as the President of the Federation of Indian Exporters Organisation for two terms and has been at the helm of affairs for two decades.



In January 2023, he was unanimously re-elected as the AMHSSC Chairman. Dr. Sakthivel has served as a long-time board member of National Institute of Fashion Technology and as a director at UCO Bank, IDBI and ECGC.

He was instrumental in implementing the third drinking water project in his hometown Tirupur under public private participation model at a cost of Rs 1,200 crores. Apart from supplying water to the roadside villages in several Panchayat Unions in Tirupur, the scheme also provided uninterrupted water supply at the doorsteps of houses and industries.
